**Environmental Health Specialist I:** *Entry-level* - The incumbent learns to perform a variety of duties for the purpose of preventing environmental health hazards and promoting and protecting public health and the environment.

**Environmental Health Specialist II:** *Mid-level* - Performs investigations and inspections relating to the enforcement of environmental health laws and regulations.

**Environmental Health Specialist Senior:** Supervisory-level- Develops, implements and manages a variety of complex environmental health programs, for the purpose of preventing environmental health hazards and promoting and protecting public health and the environment.

Environmental Health Specialist I: Conducts supervised inspections of various facilities, including but not limited to food handling and preparation establishments, schools, hospitals, detention centers, water supply and sewage disposal systems, solid waste facilities, recreation/pool facilities and other public/private facilities, to monitor compliance with all applicable laws, codes and standards of sanitation. | Investigates rodent and insect infestations and general complaints from the public and other agencies. | Conducts sampling, surveys and other methods of gathering information concerning compliance. | Under supervision of a Registered Environmental Health Specialist, may issue health permits to businesses and individuals as appropriate. | Prepares and submits a variety of reports and records as required. |

Interprets laws and regulations to the public, other departments and local agencies; recommends methods of meeting and maintaining environmental health requirements.

**Environmental Health Specialist II:** *In addition to the above:* Assists in planning, coordinating and managing the daily operations of one or more environmental health programs as assigned; functions as a resource specialist in assigned program(s) to develop environmental health policies and procedures and to recommend local ordinances and standards. | Evaluates and approves hazardous waste site remediation plans and analytical reports submitted by consulting engineers and other professionals; provides regulatory oversight for monitoring and sampling. | Assists in the provision of staff training as assigned.

Environmental Health Specialist II & Senior: In addition to the above: Responds to inquiries, concerns, and complaints from the general public and provides information and recommendations coordination with other County departments, outside officials and government agencies regarding environmental/public health issues. | Conducts engineering and architectural plan review, land division, map review, sampling, surveys and other methods of gathering information concerning compliance with Federal, State, and local laws. | Secures evidence of violations; issues violation citations and provides expert witness testimony in court or before administrative bodies as needed. | Interprets laws and regulations to the public, other departments and local agencies; recommends methods of meeting and maintaining environmental health requirements. | Operates and assists in maintaining a variety of equipment and instruments, including a combustible gas indicator, Drager Analyzer, pool test kit, camera, sampling equipment, measuring devices, etc. | Reviews, prepares and/or submits a variety of technical reports, records, correspondence, and educational materials. | Represents the Department at meetings, special events, and other public and private organizations, etc., as needed.

Environmental Health Specialist Senior: In addition to the above: Performs enforcement duties, inspections, and related tasks associated with the daily operations of one or more environmental health programs as assigned; functions as a resource specialist in assigned program(s). | Guides and assists Environmental Health Specialists and/or Aides; provides training, counseling and professional assistance on technical skills and professional responsibilities; identifies training needs and provides training for staff; assures training programs meet goals; serves as liaison between the Department and various organizations and agencies; serves on committees and task forces. | Collaborates with other professionals in investigations.
